What Is Leadership And Why Is It Important?

Have you ever been in a situation where there was no leadership, perhaps as a child in school when the teacher was out of the room? What happened? It was chaos, right?

Peter Drucker, an Austrian-American management consultant, educator, and author whose writings contributed to modern business's philosophical and practical foundations, noted that only three things happen naturally in organizations: friction, confusion, and underperformance. Everything else requires leadership. This is one reason why leadership is essential.

Leadership is the ability to develop a vision that motivates others to move passionately toward a common goal. It is ultimately about creating a way for people to contribute to making something extraordinary happen. Leadership is more about **others** than yourself.

Take a minute and close your eyes to picture a leader. What comes to mind? You may have thought of someone you admire or someone who was a leader to you. Or you may have thought of a stereotypical leader - a male, older, maybe with some gray hair indicating wisdom. Just as fashion magazines give us a stereotypical view of beauty, we also may have a stereotypical view of leadership. But the truth is, anyone can be a leader. You don't even have to have a title to be a leader. Some other leadership misconceptions are that all managers are leaders, leaders have certain personality traits and are born to lead, and that you lead all people the same way.

Leaders vs. Managers

Leadership is the ability to influence a group toward the achievement of goals. It involves directing, influencing, and motivating others to perform. Management is the use of authority inherent in designated, formal rank to obtain compliance from organizational members. Leadership is a function of management, but not all managers are leaders. Management is planning and budgeting, organizing and staffing, problem-solving, and making complex systems and people run efficiently hour after hour, day after day. You do These things every day, and you are probably very good at them. Management is still needed and important, but it is not leadership.

When I was a Postmaster, the employees in one of my offices used to refer to me as "boss." This always rubbed me the wrong way. It wasn't done disrespectfully; I just didn't like the term. I later realized the reason: boss has negative connotations. A boss drives employees, whereas a leader coaches employees. A boss depends on authority – do it or else. A leader relies on goodwill; employees do it because it helps them achieve the common goal. A boss inspires fear, whereas a leader generates enthusiasm. A boss says, "Go." A leader says, "Let's go!" There is more of a teamwork attitude. A boss commands and a leader asks and inquires. This is so important. As managers, we sometimes assume we know the problem or the solution. You may not find the best solution even if you know and have done the job. So, asking and inquiring is essential. Don't get me wrong, sometimes, you need to be a boss with some employees, but this should be the exception and not the norm.

Now, let's talk about the characteristics of leaders:

- 1. A leader must have followers. This makes sense. You're not a leader if no one is following.
- 2. There is a working relationship between the leader and the followers. There's that teamwork again.
- 3. There is a purpose to achieve a common goal.
- 4. A leader influences followers willingly, not through force.
- 5. Leadership is exercised in a given situation. It's a power relationship. Don't take advantage of that power.
- 6. It is a continuous process. There is no end to a leadership journey.
- 7. Leaders are committed to the success of every person on their team.

If you don't have 2, 4, and 5, it's not leadership; it's just bullying.

How do you become a great leader?

There are three high-level steps of leadership development. First, you need to develop yourself into an authentic leader one others want to follow. Then, you can progress to leading others. This involves developing your communication and relationship skills and mastering interpersonal excellence. After this, you are ready to lead the organization. You have the vision and strategy to lead change not only in processes but also in the very culture of the organization.

The first step in leadership development is self-management. If you can't lead yourself, how will you lead others? Some key items in self-management are:

- Coping with change. As we all know, the only thing that stays the same in the Postal Service is that something is always changing.
- Controlling emotions. Do you have that one person who knows how to push your buttons? You need to get control over that—not by making them change, but by changing your reactions.
- Being goal-oriented If you don't know where you are going, any road will get you there.
- Be willing to take risks.
- Be positive. Believe in yourself and your abilities, and be hopeful, optimistic, and resilient. This can sometimes be the most challenging change. We are all our own worst critic. But you are an incredible, amazing person!

Resilience is hard. As a leader, you will be criticized. Sometimes, others criticize you because they cannot deal with your success. You don't always have to change to criticism, but you do need to be resilient. This is all part of self-awareness.

While on the road to becoming self-aware, you need to understand your communication style and improve upon it. You also have to control your behavior. Be positive – avoid rumors, gossip, and other negative behaviors. Nothing can ruin relationships faster than rumors and gossip. If you're unwilling to say these things *to* me, you will tell them *about* me.

Be open to others and new ideas. Even if you think it won't work, be willing to listen and possibly try. Be willing to try new things and take risks.

Employ tact, common courtesy, humor, patience, and emotional intelligence. Emotional Intelligence is the capacity to be aware of, control, and express your emotions, and to handle interpersonal relationships judiciously and empathetically. This is a whole course of study in itself.

Know your purpose, set goals, always do your best, and know and develop your personality traits. For instance, if you have trouble with confrontation, work on developing that if necessary for your position or the one you are pursuing.

Improve Relationships with Others

Because leadership is about others, we reach a higher leadership level by improving our skills and relationships. How do we do this?

- Be authentic. People see right through phony.
- Develop self-esteem and confidence.
- Be a team player. So much of leadership mirrors teamwork.
- Be visible in the workplace. Don't hide in your

office behind the computer.

- Don't complain. This doesn't mean you shouldn't bring up issues. It means don't be a chronic complainer: complaining just to complain.
- Take a personal interest in the needs of your employees.
- Refuse to let people push your buttons.
- Be someone who makes others feel good.
- Develop your communication skills.

You'll notice some of these overlap with the selfmanagement which was discussed earlier.

Finally, accept other's differences. We are all individuals who learn and grow differently. You will need to use different levels and styles of leadership to successfully lead. Would you lead a 20-year veteran clerk the same way you would a new hire? Of course not.

What are the next steps to becoming a successful leader?

Take opportunities as they come. Say yes to that next assignment.

Wear your leadership role bravely – don't be intimidated; have brave new ideas and implement them. Failure is just finding a way that doesn't work.

Think long-term. You don't get anywhere overnight. Give and take criticism with grace. Don't look at criticism as negative or unfavorable. Look at it as advice and use it as motivation to improve.

Be accountable and ask for help when you need it. Sometimes, our pride stops us from asking for help. Remember, no one at any level of the organization got there by themselves.

Invest in your skills and be a lifelong learner. Invest in your skills, not just the newest postal program, but yourself. Have you done any leadership training? Have you done any recently? How are your public speaking skills? Not sure where to start? There are hundreds of results if you search for leadership courses in MyHR. There are also many YouTube videos and Podcasts on leadership. UPMA conventions are also an excellent resource for leadership training and application.

Jim Rohn, an American entrepreneur, author, and motivational speaker, has many YouTube videos on leadership. This quote of his sums up leadership perfectly. "The Challenge of Leadership is to be strong but not rude, kind but not weak, bold but not a bully, thoughtful but not lazy, humble but not timid, proud but not arrogant, and have humor without folly."

Resolution for Continuation of Illinois UPMA Chapter Dues Special Assessment

Be it resolved that the Illinois Chapter of the United Postmasters and Managers of America will continue to assess one dollar (\$1) per pay period to all active members of the Illinois Chapter to fund stipends for Illinois UPMA members to assist in expenses associated with attending UPMA events. This special assessment shall begin with Pay Period 22 FY 2024, Pay Day October 25th, 2024, and expire with Pay Period 21 FY 2025.

This fund is kept separate from the general fund and reviewed every fiscal year.

Stipends are awarded to any UPMA member for verifiable expenses incurred by attending UPMA events to include, but not limited to:

SIGNATURE FCU - A Sweetheart of a Deal

How time flies, it seems like we just celebrated Christmas, and now it's already February. I hope all of the credit union members read my column in the December issue. One paragraph pertained to keeping the credit union up to date on your current address. Effective January 1, 2025, the SFCU is no longer absorbing the \$5.00 fee charged by the USPS. It is no longer feasible for the credit union to pay this fee in this rising rate environment. If you have moved, please update your address immediately to avoid this charge. Just fill out the online form at Signature FCU.org/Address/Change.

Now is the time to make sure Signature FCU also has your correct cell phone number and email on file. We need this information so you may receive Visa alerts, or approve or deny flagged charges. If the charge was authorized by you, all is well; otherwise, we will freeze the card. Just go to Signature FCU.org/UpdateForm.

Be a 2025 Scholarship applicant. Apply for our essaybased scholarship for the chance to be one of three winners awarded \$1,000/each. This year's essay topic is: What is Your Biggest Strength and How Will You Utilize it in Your Career? You have until midnight on June 20th for the credit union to receive your entry to be considered. To view all the requirements and submit your 250–500-word (typed and double-spaced) essay, visit SignatureFCU/Scholarships.

Our EZ Save Certificate can be opened with a \$50 minimum deposit. It has a 12-month term, and you can make additional deposits anytime by mailing a check, setting up a payroll/retirement allotment, Online Branch

or Mobile App transfer, or even transferring funds from your local financial institution. The current rate is 4.40% APY and the limit to deposit is \$25,000. After 12 months, you have the opportunity to transfer the balance to another Share Certificate. Only one EZ Save Certificate per account. All your deposits are federally insured up to \$250,000, by the NCUA. For more information about Signature EZ Save or to open a certificate, please contact one of our qualified representatives at (800)336-0284.
