



### Edmund Carley~ Illinois State President

I am very proud of our Illinois delegation that managed, despite the challenges of mail count, to get to go to Washington, DC this year for the Legislative Advocacy Summit. Under the leadership of our IL VP for Legislation, Marianne Miller, our message was taken to The Hill and was well received by all accounts. Marianne arranged all the visits and, with a few last minute changes, every Member of Congress and both Senators received the UPMA message. Well done to all that made the trip but also to those who couldn't, it is important to remember that we can still

influence at home. Call your representatives today and keep calling until we get Postal Reform.

For whatever reason the Postal Service doesn't take us seriously when it comes to our consulting with them on working conditions, pay and benefits for UPMA members. I am not just talking about the ongoing pay talks. I find, at every level of the organization, the attitude is that although my concerns are warranted and reasonable, somehow, I should just accept that some things are just the way they are and stop fighting for what was right. I should just accept that two career clerks in every level 18 office is a pipe dream. The vague and discriminatory way the CCA cap is being allocated based on whim not complement, especially in the more rural areas is something I should just overlook. Postmasters having to endure multiple Investigative Interviews over a situation that aren't intended to discover anything, just to instill fear and intimidate is the price of doing business and I should ignore the practice. I must be crazy to think that Postmasters are being micro-managed to the point they are becoming afraid to make a decision. I am also told to believe that there are no District-wide mandates that require exempt employees to work for free in order to avoid paying overtime to special exempt employees.

Well, here's the thing; UPMA is not going to stop fighting for its members, UPMA realizes that the Service is in a tough spot financially but the Service has to realize that Postmasters are the solution to that problem, not the cause of it. So, what can you do to help us in helping you? First, become active; come to State Convention, come to 3 digit meetings, reach out to non-member offices and recruit them to join the organization. Support UPMA with your time and effort and UPMA will repay you by making sure that your working conditions don't continue to suffer. There are almost 200 Postmasters in Illinois who aren't members of UPMA; help us to recruit and activate these potential members and we will have a stronger more unified voice. Stand up for what is right in your own office. For example, if you are required to work outside of your Form 50 hours simply to avoid the payment of overtime to another employee stand your ground and don't do it. If your POOM is a bully, call them out and contact UPMA. If your office is deliberately being understaffed, contact UPMA and let us file a consultative issue log. I know it's hard, I know no one wants to rock the boat but it is harder for UPMA to challenge bad decisions made by Districts, Areas and Headquarters if Postmasters make it look like there are no problems. Exempt employees are being exploited because of their own good nature; be less good natured! Remember; Together We Can.

# Contact your Congressman

On February 12th, the 2019 Federal Budget submitted to Congress that if approved would contain more than \$155 Billion in cuts that would affect active and retired federal employees. Among the provisions contained in the budget:

~ Increase employee retirement contributions ~ Eliminate cost of living adjustments (COLA) for FERS and reduce COLA for CSRS ~ Abolish the FERS supplement Annuity for retirees prior to Social Security eligibility ~ Change the computation formula from high 3 years salary to high 5 years salary ~ Reduce the interest rate of earnings for the G fund in the TSP

The US Postal Service is the only entity - public or private - required to prefund its retiree health benefits. Our agency emerged from the recent recession seriously wounded by this prefunding obligation. The payment for this prefunding obligation in FY18 was \$6.7 Billion. Absent this annual multi billion dollar burden, the Postal Service would have realized operating surpluses.

For the reasons above, your organization, United Postmasters and Managers of America (UPMA) supports HR 756, the bipartisan "Postal Reform Act" and looks forward to to supporting a Senate Version of the bill.

Please contact your congressional representative and let them know of your support of (House Resolution) H.R. 756. Consider attending state convention in Peoria in May and learn the latest update to this very important bill that affects all of us.

In the afternoon we went to the Capital Visitors Center to meet with the Senators and aides. Senator Meadows is the touch point for getting support. He said this is a bi-partisan bill which is a rarity in this congress.

If you are 65 or over the metro pass which costs two dollars gives you discounted fares even in peak time. You just tap it over the gate and away you go.

Tuesday afternoon our congresswoman Cherie Bustos met with Pam Bardell, Dixon; Marianne Miller, Winnebago and myself. Edmund Carley and his daughter we able to join us at 30 Ivy Street. The congresswoman came to us. While others had to meet with their representatives ours came to us. It really is a good idea to meet with your representative in your home district and build a relationship. I am going to have lunch with her at a fund raiser in Fulton on Saturday. As a retiree, I am able to attend functions and have no restrictions on lobbing our congress.

I hope you are planning to attend the State Convention in E. Peoria. As a retiree you can vote on the location of our next state convention. I hope to see all of you there.

The origin of the term comes from the

requirement of having mastered certain skills, and gender never entered into it."

I liked that clarification because it made me feel like someone thought I had all the skills it took to run an office – "to master the mail" – and I was proud of my job. Generally, I am proud to be a postmaster, but do I still believe I have all the skills it takes to "master the mail" and run an office now 13 years later?



I feel more optimistic, after this trip to our Nation's Capital, than ever in the 12 years I have attended previously. Members of Congress were the most receptive to the idea of passing Postal Reform Legislation, even willing to co-sign and bring pressure to bear on their colleagues to get a floor vote as soon as possible. HR 756 is not a perfect bill but we were told repeatedly that it must pass before May 1st to have any chance of becoming law in time before the next election cycle starts this fall and we would have to wait for the next Congress. UPMA members did some great work in Washington, DC; The Deputy Postmaster General, and USPS Chief Government Relations Officer, Ron Stroman said it best when he praised UPMA activists from the podium on Monday February 26th, 2018. We are the best advocates on The Hill that the Postal Service has, it was our direct influence last year that produced HR 756 being passed out of committee and it will be our pressure that gets it passed now. Others will assist but never doubt that UPMA is the driving force for meaningful Postal Reform, Postmasters always have been, it is now on Congress to do the rest.

One of the problems with HR 756 is that while it addresses the Medicare integration, it has no mechanism by which to pay for it. There were rumors of a Senate Bill that may fill that gap but as of today, nothing has been forthcoming. It is important that the Senate also passes a Postal Reform bill or commit to considering 756 when passed by the House. If Senators pass a companion Bill then it and HR 756 will go to a conference committee and any product of that body will have to be reconsidered by both chambers before going to the President for a signature. So, we are a long way from Postal Legislation but now at least we have momentum and a time frame. We must keep the pressure on as much as possible. Call your representatives today; tell them to support HR756 and keep calling them until something gets done.

The Postal Regulatory Commission also announced its preliminary findings after the 10 year review of the Postal Service's pricing system established by the PAEA Act of 2016. It appears that the consensus is that, even with Congressional action, the business model of the USPS is not capable of sustaining the Service long term. Along with the passage of a Postal Reform Act it may be necessary for some real regulatory system changes. Right now there are no independent members on the Board of Governors; the PRC has little or no regulatory power over the Service and the Service can't implement the changes it needs to without the governance model being repaired and/or drastically changed. Having said all that, I am optimistic we will prevail soon and if we don't, rest assured we will still stay engaged. UPMA will reevaluate the needs of its members and interact with Congress in a way that betters the working conditions, pay and benefits of Postmasters, Supervisors and Managers. We will figure this out and we will prevail, I am confident in the power of our message and the passion of our messengers; together we can.



### Greetings my fellow UPMA Members:

Soon you will have the opportunity to attend your chapter convention and be part of UPMA history. You will have the opportunity to cast a vote to help determine who the first elected National President of UPMA will be. In addition, you will also have the chance to vote for up to two National Vice Presidents and the chapter officer positions that are up for election this year.

Our UPMA By-laws are specific on how the voting will take. At each of our chapter conventions each active member registered for the convention will receive a ballot. Then the votes will be tallied and based on the percentage cast for each candidate that is how your chapter's electoral votes will be cast at the National Convention in Reno in July. To use round numbers: if there are 30 people at the convention and 20 vote for one candidate and 10 vote for the other, you votes would divided 66.6% for candidate one and 33.4% for candidate two. So, if your chapter has 21 electoral votes, candidate one will receive 14 votes and candidate two will receive 7 votes. As a result, every vote is very important.

As a candidate for National President, I would like to request that you cast your vote for me. I feel I have the knowledge and experience to serve you as your national president.
