



GOING VIRAL

As I write this article the world is at odds with the Corona Virus. After hearing Postmaster General Brennan speak and visiting our Representatives in Washington DC, one thought that looms in my mind is, what impact is this virus going have on the US Postal Service?

After 9/11/01 we experienced a massive decline in our economy. In 2008 we experienced yet another devastating blow to our economy, coupled with the 2006 Postal Accountability and Enhancement Act (PAEA) which mandated prefunding of retiree health benefits to the tune of over five billion dollars a year. Ever since

then the Postal Service has been struggling to meet its needs and be able to reinvest funds back into the infrastructure. And now, we have the Corona Virus to tend with. We have already begun to see effects on the world wide economy, and we are just beginning to feel its impact. It will take months to determine the full impact on the world economy.

The DC Summit was very interesting this year. We heard some brutally honest assessments of the state of the Postal Service and Congress' willingness to work together on legislation to keep us solvent. PMG Brennan made it very clear that we need legislation now. She did not mince words or add any fluff; we will be out of cash in three to four years. I have been attending the Legislative Summit for approximately ten years and the attitude of urgency was evident in her manner, voice, and words. Every year we stress the importance of postal reform legislation, yet for me this year the message seemed more ominous. I liken it to a speeding train about to go off the rails. Do we be proactive and try to stop it before it careens out of control, or do we wait and react to the aftermath and the damage it creates? Please bear in mind that PMG Brennan was to retire at the end of January 2020. The next PMG will have an even harder hill to climb with this latest boulder tossed onto the path of Postal Service recovery. We need to be proactive in reaching our Representatives and Senators, and continue to commend those in support, and encourage those who currently are not.

The media is interviewing and covering stories of how Congress will act to support the American economy amidst this pandemic. I would personally like to ask Congress what they are planning to do to keep the US Postal Service alive amidst this latest world-wide trauma. The House of Representatives passed H.R. 2382: USPS Fairness Act in early February (309 to 106). We are truly thankful to the Representatives who sponsored and fought for the passing of the resolution; amongst them were Representatives Rodney Davis, Darin LaHood, Mike Bost, and Adam Kinzinger. After our Hill visits, Illinois sponsored a dinner with the aforementioned Representatives as our guests of honor. Representative Kinzinger was unable to attend due to being on his honeymoon.

We were a bit tentative initially as this was the first time we had guests of honor at our state dinner. As the evening progressed we enjoyed wonderful conversations with the Representatives. They understand the importance of the Postal Service to the United States as a whole, to the individuals within our communities, and why our founding fathers thought it necessary to have it written into our U.S. Constitution. Their support and the support of other representatives is a glimmer of light in the darkness.

Prior to leaving the Hill a few of us were able to meet with Senator Durbin at the Capitol. The meeting was arranged by Brian McLaughlin from Imperium Global Advisors, to whom I am extremely grateful. The discussion was led by Edmund Carley, our Chapter President and UPMA National Executive Vice President and Legislative Chairman. I would love to say that the conversation was encouraging, but I would be lying. The Senate is not planning on working towards passing any Postal Reform resolutions any time soon. At the time, they were more concerned with elections. Now, I believe they are more concerned with the Corona Virus. I also believe it is important for us to continue to be in contact with our

Senators; to educate them on the importance of the US Postal Service to the economy, and to the fabric of the nation. They would never dream of not having a Congress. They are one of the three branches of government delineated within our Constitution. We need to keep up the pressure; perhaps a written reminder that the Postal Service is also delineated within our Constitution, as a specific line item within their duties.

I would like to thank our first time attendees to the DC Summit; Anne and Patrick Balsley, Katie Levernier, Kasey Simmons and Doug Carroll. Their input during the meetings was insightful and valued, as we had some alternate viewpoints regarding the importance of the Postal Service within our communities from people who are not postal employees. Thank you for taking the time to join us at the DC Summit. My hope is that you join us again next year, and bring a friend!

I would also like to thank our advisors for making arrangements for meetings, a "huddle room" on the Hill, pinch-hitting at visits, providing valued advice, being the calm in the storm, and many other behind-the-scenes activities. Thank you Brian McLaughlin, Chris McCannell, and Joel Reithmiller for your continued support of our mission and for your wisdom and enthusiasm in helping us accomplish our goals. I look forward to working with you throughout the year.

This year UPMA had more attendees than expected which made the event planning a very fluid process. Due to that fact, we moved our first day of the conference to the Hyatt Hotel which is located across the street from the Renaissance Hotel. Thank you to UPMA Headquarters for working hard and making all the arrangements; for making the changes seamless to those of us in attendance. You did a fabulous job! The Postal Service is in a very precarious position. As Postmasters and Managers we are going to continue to feel the heat as the funds dwindle and we receive little support from Congress. I suggest we deflect the heat we are feeling directly onto Congress. For every telecom you must be on and hear that you must pick up the slack - write your congressman and congresswoman. For every day that you must work over your Form 50 days and hours - write your congressman and congresswoman. For every vacation day that gets left on the table because your office does not have enough staff to cover the time - write your congressman and congresswoman. For every time an LLV breaks down and has to be towed because we do not have the funds available to purchase new vehicles - write your congressman and congresswoman. The message to our elected officials that they need to act, and to act now, needs

I was reading an article in our Credit Union magazine recently on increasing membership. It stated many people think credit unions are just for making loans or for setting up a savings account. Worse yet they thought if the credit union wasn't located nearby their funds would not be reachable from where they live. Perhaps we need to make it more clear how to join and who can join and how easy it is to reach

us. People need to think "credit union" when they think checking account, vehicle loan, credit card, mortgage, etc. If you are still not a member but are interested in joining just call our office at 1-800-336-0284 and sign up over the phone. They will explain all the various cards we offer and help you decide which one is best for you.

Every year at State or National Convention it seems attendees sign up as a member, pay the \$5.00 fee and then nothing more is every done. This results in members being sent a letter that their account is inactive and they need to make only one transaction per year to keep their account in active status. Here are some of the options to keep the account active:

- 1. Apply for a Visa card and make at least one yearly transaction.
- 2. If you already have a Visa card perhaps it needs to be activated (or maybe it is expired).
- 3. Make a deposit by mail for a little as \$5.00.
- 4. Or set up a recurring ACH from your local bank, OR
- 5. Set up a one-time transfer from your local bank.

Have you members signed up for a My Card Rules app.

Just go to MyCardRules app and register your cards to receive push notification for purchases, freeze/un-freeze your card in the event it is lost or stolen, and set international card preferences for travel. Just go to SignatureFCU.org/Protect-My-Card

How about personalizing your Credit or Debit Card with Create-A-Card?

Choose your favorite family photo, vacation photo, or even feature your family pet on your card. We also offer a gallery of images to choose from including images in categories such as sports, patriotic, monuments and summer fun. Start designing today at SignatureFCU.org/createacard.



We will be electing a Chapter Vice President, Chapter Secretary and a Chapter Treasurer:

Secretary

Shall keep all records, record the proceedings of all conventions and meetings of the executive committee.

Treasurer

Shall be bonded and shall deposit, withdraw and have custody of the funds of the chapter, be responsible to keep an accurate and complete account of the receipts, vouchers and membership.

One of the 3 At-Large Vice Presidents positions; they will be responsible for the one of the following duties: Education Chair

It will be their duty to work with the President in aligning training that is deemed necessary and appropriate for the membership.
