


# **National Convention**



I was able to be at UPMA National Convention in St Louis, MO. It was a much different convention than ususal. Our seats were 6 feet apart so we could remain socially distant and everyone had masks . I want to thank Meta and Roger for getting me down there. I broke my leg Labor day weekend and was hesitant to drive myself . Congratulations to Jim Dunlap from Colorado and Jim Maher from Missouri who were elected as National Vice Presidents from the West and Susan Rice from Alabama, who was elected as National Secretary-

Treasurer. We adopted a bylaw change with UPMA, now electing one vice president each year from four geographical areas instead of two from the east and the West as we did this year. Illinois is in the North Area with Iowa, Indiana, Kansas, Kentucky, Michigan, Minnesota, Missouri, Ohio, North Dakota, Nebraska, South Dakota, and Wisconsin. Mari Beth Kirkland from Ohio announced her Candidacy for election during the 2021 Chapter Conventions. Our very own Edmund Carley also announced for National President.

During the convention, other proposed changes to the UPMA Articles of Incorporation and the UPMA National Bylaws were voted on. The following changes were adopted: Articles of Incorporation changes #1, #2, #3, and #5; UPMA National Bylaws changes #1, #3, #4, #5, #6, #7, #8, #9, #10, #11, and #14. The remaining proposed bylaw changes did not have sufficient votes to be adopted: changes #12, #13, #15, #16, #19, #21, and #22. Articles change #2, and the submitters withdrew bylaw changes #2, #17, #18, and #20 before consideration at the convention. All the changes are still posted on the national website unitedpma.org if you want to look at them. The updated Articles of Incorporation and the National Bylaws will be published in a UPMA Leader's upcoming issue and posted on our website. Please note that any proposed changes for consideration next year need to be submitted to the National Office by February 1, 2021.

Postmaster General Louis DeJoy addressed the convention and was very candid and forthcoming with the many challenges he and the service faced since his swearing-in. He promised a staunch defense of 6-day universal service, and all changes that will be made will sustain the USPS for years to come. He appeared frustrated by some of the enormity of the job but excited for the challenge. Time will tell how well we all do. We took care of business at this extraordinary convention; but I cannot wait for a "more normal" one in Ohio next year.

Leadership

Not all managers are leaders, and not all leaders are managers. Just being in charge doesn't automatically make you a leader. Manager of Labor Relations Shayne Hensley spoke on this topic at the Southern Officers Conference in Atlanta, Georgia.

Leaders must lead. It's not simple, but it is that easy. If it were simple, everyone would be doing it. So,how do you become a good leader?

You must realize that as a leader, you are no better than anyone else. Once you lose sight of that, it'sover. Proclaiming your superiority and ruling with an iron fist because you're the boss will cause your team will work to comply, but not to excellence.

You must have a vision to share a vision. As the old saying goes, look before you leap. Where are you going? Where is your team going? If you don't know, you'll never get there. Have goals for yourself and your team and share them.

Know your role. As a postal manager, you likely have been promoted through the craft ranks. You may have been the best clerk or carrier in your unit; however, you are no longer in that position. You are the leader, and you need to let the other people do the work. Sometimes it is easier to just do it yourself. In doing so, you prevent your team from learning and growing.

Along those same lines, know the roles of your team. Don't let others give you their work. Give them what they need and let them succeed. Listen to those you lead. They may not know what they need, butif you listen closely you can figure it out. There was a great article pubblished in the Harvard Business

"Ask your team for their thoughts and input"

Review titled Who's Got the Monkey, which is about making sure your employees keep their work.

Know your role and your team members' roles and never get them reversed. Give them credit and take the responsibility. As you grow your team, they will produce excellent results. Make sure you give them the praise and credit. Nothing will stifle an employee more than you takingcredit for their work. Being human, everything will not always work out perfectly. Don't play the blame game. When a project or team member fails, as the leader, you take the responsibility for the failure. What could you have done better to help them succeed? If you lose faith in your team, they will lose faith in themselves.

Always use failures as a tool to learn to grow and succeed. The steps to leadership may all be the same, but the style of leaders can vary greatly. You need to figure out your leadership style. You will use all leadership styles, but there will be one that you naturally lean towards. If you use Coercion to lead this means you demand immediate attention. Think of a drill sergeant. I say it, you do it. While some situations will require this type of leadership, this should NOT be your primary leadership style. If this is the way you lead, you will be perceived as a bully. As an Authoritative leader, you tell your team, come with me; we can do this together. You find it easy to share your vision, and because of this, people naturally want to follow you.

An Effective leader understands people. You care about people outside of their work. You know what they need and what makes them tick. Once you get this down, people will do things for you and you won't even have to ask.

The Democratic leader gives their team a voice. Although they will make the final decisions, they never fail to ask their team for their thoughts and input.

A Pacesetting leader drives their team to succeed. Think of a personal trainer encouraging you to get in one more mile or 10 more pushups. This is another style that should not be a go-to, but may be needed in some situations. Using this as your primary style can exhaust your team.

The Coaching style will help you develop people. A coach leads by giving opportunities. If you use the coaching style, you will let your team do what they need to, then give them feedback. Ensure you use both positive and negative feedback. Only focusing on the positive will inhibit growth and all negative feedback with quickly squash the most enthusiastic team members. When you need to give negative feedback use the sandwich method. Sandwich the negative between two positives.

Sounds simple, right? But how do you accomplish all of this? Where do you get the tools you need to lead others?

There are many resources available to leaders. Let's start with education. You can take courses at a local community college, or access HERO for development opportunities. We all take our required courses in HERO, but there is a myriad of courses available that you can take to help develop yourself. Focus not only on leadership courses but the courses that your team members need to do their jobs. How can you help them if you don't know what they are supposed to be doing?

As part of this self- development, you can also become a Subject Matter Expert in something. Your manager or the area and district offices are always looking for individuals to assist. Becoming an expert in something will help you develop as a leader.

Networking is also a great way to get assistance. Use the expertise and knowledge of others in similar positions. This can be challenging if you are the only EAS employee in your office. UPMA offers numerous events that can help you network. State and National conventions and 3-digit meetings are great places to meet others that know what you are going through and how to help. And if you are already a great manager and leader, these give you a chance to give back and develop future leaders. Your experience will also give you the tools you need to lead the workforce. There is no substitute for experience. You can learn the mechanics of open-heart surgery from a book or a web site, but you will not know how to do it until you actually do it. Also, learning from your mistakes ensures you will rarely make them again.

You can also learn to lead from those you lead. Don't let your pride set in and get the mindset that you have to know everything. The people you lead have a lot of knowledge. Use it.

One of the best places to get the tools to lead is from within. Be the best employee you can be. Whether you are currently in a management position or not, remember, bad employees, make bad leaders. It is very hard to be a good manager if you are a bad employee. Do you arrive on time every day? If you are constantly late, there is a good chance your employees are going to be late too. Have the highest level of integrity. No one wants to follow someone they can't trust.

Even if you are the best leader, there will still be things that can crush your leadership. Whisperings, rumors, gossip, murmuring, or mumbling from your team can all put a strain on your leadership. You need to be aware of these things and communicate with your people. Bad things happen when we don't communicate. Is there a rumor that your facility is going to close? Don't just ignore it. Address it with facts.

Personal conflicts and bad attitudes can also negatively affect your team. Personal communication with employees can help these things. Don't just know the job. Know your people. You can't just say you care; you have to show you care. Some people are not the easiest to get along with, but you have to love people. This is a decision. It isn't always easy, but it is worth it.

Busybodies can be terrible for a team. That person that is always stirring up things or keeping others from doing their work. The easiest way to stop this is to give them work.

The simplest way to crush your leadership effectiveness is your own doing. It is neglect. You cannot neglect your team. They are doing good, I will just leave them alone may be good for certain times and projects, but in the long term, a neglected team will fail. Just as your car will stop working if you fail to maintain it, so will your team.

When you get to the point that you just don't know what to do, reach out to a mentor or work friend, someone who knows what you are going through. Make sure you leave work at work and take breaks. Being burnt out will keep you from being an effective leader. Make sure you have a life outside of work. Family and friends give you the lift you need to continue to be effective at work.

And finally, remember, your team did not pick you; you picked them. You chose to accept this position. You will change people's lives and their families. You owe it to them to be the best you can be. When you have retired, the ultimate test to success in your career won't be how much money you've made, or the position you aspired to, but how many people you touched on your journey. Where is your team going?

Then they will be placed onto the agenda and offered up for discussion and vote at the State Convention in March 2021.

# BYLAWS OF THE ILLINOIS CHAPTER UNITED POSTMASTERS AND MANAGERS OF AMERICA RETIRED (EFFECTIVE 7/11/20)

#### **Preamble**

The purposes for which this Chapter is organized as a part of the national organization, United Postmasters and Managers of America (UPMA) Retired, shall be to promote, assist and instruct retired Postmasters and Managers in all areas of personal and related items of interest or concern and to work cooperatively in the advancement of national UPMA Retired aims and goals.

Article I – Name

This organization shall be known as the Illinois Chapter of United Postmasters and Managers of America (UPMA) Retired.

Article II – Membership

Any person as designated by the UPMA Retired Bylaws to be a member of the national Organization shall be considered a member in this Chapter but no member in arrears for dues shall be recognized or permitted any of the privileges at its conventions.

Article III – Meetings

The Annual Convention of this Chapter shall be held in conjunction with the UPMA Illinois Chapter Annual Convention. Special meetings may be called by the President, and shall be called on the request by a majority of the Executive Board or on demand in writing of ten (10) percent of the paid up membership of this Chapter. The Chapter Secretary shall give notice of meetings to members of the Executive Board at least ten (10) days prior to the date specified for such meetings. In any convention

of this Chapter, all members who are present and registered for the convention shall constitute a quorum.

Article IV – Election of Officers

Section 1: The elected Chapter officers shall be a President, an Executive Vice President, one Vice President, and a Secretary/Treasurer.

Section 2: The President, Executive Vice-President, one Vice President and Secretary/Treasurer shall be elected at the annual Chapter Convention to serve a term of 2 years. An elected officer may not serve a consecutive term in the same office. The term of office shall commence on November 1 and will end on October 31.

Section 3: The election of officers shall be conducted at the annual Chapter Convention. Candidates to be elected to respective offices must be present when their name is placed in nomination. Members in good standing who are registered for the annual Chapter Convention and present when ballots are cast are eligible to vote in Chapter officer elections. Elections shall be by majority vote cast by ballot. In the event that no majority is reached, the two candidates with the most votes will compete in a run-off election. Where no contests exist, election may be by acclamation.

#### Article V – President

The President shall preside at all meetings of the Chapter, shall call special meetings when requested to do so as provided in Article IV. They shall also preside at the meetings of the Executive Board and appoint all committees for the proper handling of the business of this Chapter and in general perform such duties as may pertain to the office. The President shall receive such compensation for their services as the Executive Board may provide. The President shall be elected to one two-year term in odd numbered years.

Article VI – Executive Vice President

The Executive Vice President shall serve in the absence or disability of the President and work with the President as needed. This position may be a separately elected position. Should the office of the President be vacated, the Executive Vice President will serve the remaining term. This would not exclude that person from seeking a full elected term as President. The remaining term of the vacant position of the Executive Vice President shall be filled by the elected Vice President. In addition, the Executive Vice President will serve as the Membership Chair for the Chapter. It shall be their duty to promote membership for the organization and ensure that the Chapter always has a strong membership.

The Executive Vice President shall be elected to one two-year term in even-numbered years. The Executive Vice President will also assist the State Convention Chairperson arranging events/programs for the retirees at the annual convention.

#### Article VII – Vice President

One Vice President is elected by the Chapter. The Vice President will serve as the Bylaws Chair. It will be their duty to receive, evaluate, and recommend for official action all proposals for amendment of the Bylaws. If a vacancy should occur in the office of Vice President, the President with the consent of the executive board shall appoint a replacement to fill the unexpired term. This would not exclude any person, filling an unexpired term, from seeking a full elected term as Vice President. The Vice President shall be elected to one two-year term in odd numbered years. The Vice President will chair the Scholarship Committee. In the event that a relative of the Vice President is an applicant for a scholarship, the Vice President will be recused, and the Immediate Past President will chair the Scholarship Committee.

#### Article VIII – Secretary/Treasurer

Section 1: The Secretary/Treasurer shall take the minutes of meetings, handle correspondence, and make reports as required and other duties as assigned by the President and shall receive such compensation for their services as the Executive Board may provide.

Section 2: The Secretary/Treasurer shall keep all financial records; have custody of all funds; deposit

and withdraw them upon approval of the President and shall keep accurate and complete accounts, vouchers and receipts, provide a financial statement at the annual meeting of the Chapter and perform other duties incident to the office of Secretary/Treasurer.

Section 3: The Secretary/Treasurer shall be bonded as required and approved by the Executive Board and shall receive such compensation for their services as the Active Executive Board may provide. This coincides with Article X.

Section 4: The Secretary/Treasurer shall be elected to one two-year term in even-numbered years. If a vacancy should occur in the office of Secretary/Treasurer, the President with the consent of the executive board shall appoint a replacement to fill the unexpired term. This would not exclude any person, filling an unexpired term, from seeking a full elected term as Secretary/Treasurer.

Article IX – Executive Board

Section 1: The officers of this Chapter shall be a President, the Immediate Past President, Executive Vice President, one Vice President, and a Secretary/Treasurer. The Immediate Past President shall serve a term of 2 years beginning on the first day a newly elected President assumes office. These officers shall constitute the Executive Board and the governing body of the Chapter. With the exception of the Executive Vice President, all Executive Board members will serve on the Scholarship Committee. Should the family member of an Executive Board member be an applicant for a scholarship, the board member will be recused.

Section 2: It shall be the duty of the Executive Board to carry out the orders of the Chapter as expressed in the convention, it shall have direct control of all business of the Chapter and its affairs, it shall be the power of the Executive Board to authorize necessary expenditures; to audit all accounts; approve the expenses of the officers and in general perform all the functions ordinarily attached to such committee. The Executive Board shall have full control of the affairs of the Organization between conventions.

Section 3: The Executive Board shall have the power to remove any of its members for good and sufficient reason by two-thirds (2/3) vote of the board when in session.

#### Article X - Bonds

The Secretary/Treasurer will be required to be bonded in the amount deemed sufficient by the Executive Board, said bond to be executed by a surety company approved by the Executive Board and the premium on such bond shall be paid by the Active Chapter of the membership.

#### Article XI– Dues

The annual dues of the members of this Chapter shall be the same as provided in the governing documents of the national organization.

#### Article XI1 – Parliamentary Procedure

Robert's Rules of Order Newly Revised shall govern the deliberations of the proceedings at any session of a UPMA Retired Chapter Convention or other meeting of this Organization, except that where any provisions of these By-laws are inconsistent or in conflict with Robert's Rules of Order Newly Revised, then these By-laws shall prevail.

#### Article X111 – Amendments

All proposed amendment(s) must be submitted in writing to the UPMA Retired Chapter President at least thirty (30) days prior to the opening of the annual Chapter convention. These By-laws may be amended at any convention of the UPMA Retired Chapter by a two-thirds (2/3) vote of the delegates present and voting. These amendment(s) shall become effective immediately upon the adjournment of the convention unless otherwise specified in the amendment.

#### Article XIV – Publication

These By-laws shall be printed in the Illinois Postal News Leader or on the IL UPMA website. After the initial printing, any approved changes will be printed and updated in the above mentioned

publication.

Article XV – Control of Funds

Section 1: All expenses incurred by officers or members necessary to fulfill their duties and obligations for the benefit of the organization, shall be approved by the President and paid by the Secretary/Treasurer from available funds.

Section 2: The Retired President will be included in all expenses of the Active Executive Board. Section 3: Two days lodging and mileage at 75% of the rate paid by the USPS shall be paid for attending the State Convention to the Retiree Secretary/Treasurer, Immediate Past President, the Executive Vice President, and the Vice President.

Section 4: The lowest registration fee established by the UPMA National Board for the Annual National Convention will be paid for attending the Annual National Convention to the Illinois UPMA Retiree Secretary/Treasurer, the Executive Vice President, the Vice President, and the Immediate Past President.

At this time, I would like to announce my intention to run for the North Area Vice President. I was a member of the LEAGUE/NAPUS, since I became a Postmaster in 2002. I joined NAPUS on my second day, as a titled Postmaster. I attended my first Legislative Conference, the second week, after my first appointment.

I began my Postal career with the USPS, as a PTF Clerk. I served in that position for almost 12 years, before starting my management career. I was appointed as a Level 11 Postmaster, and have served in Levels 13-21's. Currently, I am a Level 20 Postmaster, in Middlefield Ohio. Throughout my career, with the USPS, I have served on several details. I facilitate for Headquarters', the Area, and districts, for programs such as, Postmaster Essentials, USPS Supervisor, and FST.
