

### Stay on Top of Postal Reform Legislation

As you may know, Edmund resigned as Illinois Chapter President on March 31st so he could concentrate on his run for National President. I was elected to finish his term and will proudly serve Illinois in his absence. What an honor it will be to have an Illinoisan represent UPMA members nationally! He is currently running unopposed. The election will be held during the UPMA National Convention in Sandusky, OH. If you haven't registered to attend, please do so. The Illinois Board voted to help offset the cost of going, and it would be great to have as many people as possible there to support Edmund.

For the convention, the Ohio chapter has selected to sponsor Soles for Souls, which is part of the Funds2Orgs.com group. Soles for Souls started with a single shoe which washed up ashore after the 2004 Indian Ocean tsunami. Wayne Elsey, then president of an international shoe manufacturing company, went on to establish one of the largest nonprofits in the United States. Soles for Souls has helped people affected by significant natural disasters including Hurricane Katrina, the 2010 earthquake in Haiti and the aforementioned Indian Ocean tsunami. Mr. Elsey led efforts to ship more than 20 million pairs of shoes to people in places hurt by natural disasters. Chapters can choose to participate by collecting gently used shoes to be donated. These shoes can be childrens or adults, but please be sure they are gently used or new. This is a good cause. If you're interested in donating shoes, please let me or any officer know and we'll make arrangements to get the shoes to Ohio. The shoes will be donated around the world in the name of UPMA.

The US House of Representatives Oversight and Reform Committee conducted the mark-up of a Postal Reform bill last Thursday. The bill passed on a voice vote with bi-partisan support. When the time comes, we will need each of you to reach out to your member of Congress to remind them how important this bill is and to get it across the finish line. We all need to do our part and "be part" of getting this Postal Reform bill passed!

All EAS are non-bargaining unit employees, paid on a salary basis; this means that under the Fair Labor Standards Act (FLSA)

they are not considered hourly rate employees. Therefore, using less than full-day leave for partial-day absences is not allowed. Most Postmasters and Managers are also FLSA-exempt employees and consequently eligible for Personal Absence Time (PAT). The ELM section 519.71 defines PAT as paid time off that is not charged as annual leave, sick leave, or any other paid leave category.

Typically, PAT is limited to no more than half an employee's workday. However, when an exempt employee receives a direction to work a full day on a holiday or other full day in addition to regular workdays, the employee may take a full day of PAT without charging it to official leave (ELM 519.733).

Postmasters and Installation Heads, typically, are not required to obtain advance approval for personal absences. However, they must keep an accurate record of all such absences and generally keep their manager informed of planned periods away from the office. PS Form 3971 should be used to record PAT and must indicate in the remarks section the phrase "Do not charge to leave."

Just as Postmasters are responsible for controlling the work hours of craft employees, their managers are responsible for managing the work hours of exempt employees who report to them. Increasingly, Postmasters and other EAS are required to work outside of regular service hours and schedules. The intention is that Personal Absence Time rules are not to be overly restrictive; however, managers must be aware of the frequency of requests for personal leave, recognize patterns in the use of this leave, and be alert to possible abuse. They must also consider the current workload or urgency of a particular program or project requiring the Postmaster's presence.

The administration of this program must be fair and equitable (ELM519.752). Managers must advise their employees of the reasons for requiring their attendance outside of regular service hours, and employees should also get the opportunity to discuss those decisions informally.

When an exempt manager is directed or required to work on a non-scheduled day or a holiday, they are entitled to take a full 8-hour day of PAT sometime in the future; it is no longer required to be in the same pay week. The 3971 below is an example of how J Q Postmaster worked the Saturday before Memorial Day and is taking off the day after the 4<sup>th</sup> of July. The critical thing to remember is the phrase "Do Not Charge to Leave". Also, enter all leave into eRMS and keep copies locally.

Postmasters can schedule up to 40 hours of their own Annual Leave without approval but must send all 3971s and any other documentation to their Manager, Post Office Operations, for information purposes. Full-day personal leave cannot be "banked", and its use should be sparing, but as the postal business evolves, it will become more prevalent.

## WASHINGTON, DC

Greetings everyone! The UPMA 2021 Legislative Summit will be held September 26<sup>th</sup> thru September 29<sup>th</sup> in Washington, DC. UPMA's number one goal is comprehensive postal reform that will ensure the USPS has the right financial and strategic footing to continue to serve all American households and businesses. If we are going to be successful in achieving comprehensive postal reform we need to show up in Washington as a large collective group and meet with all 18 Illinois members of the United States House of Representatives and let them know how vitally important postal reform is needed for the USPS to stay in business and how we need them to support this bill. Simply put, there is strength in numbers and the more UPMA members that show up, the better our chances are for securing their support. We will not be going to Washington as a member of any political party. We will be going as members of the United Postmasters and Managers of America! This is important because we need bi-partisan support in order for this postal reform to pass. There is no other way.

On the 3<sup>rd</sup> Wednesday of every month UPMA holds a national legislative Zoom meeting. In our previous meeting we discussed three things the postal reform bill would do. First, it would get rid of the unfair requirement for prefunding retiree health care benefits that have unfairly only been required for the USPS. Secondly, it would allow for integration into Medicare of retirees' health care, providing postal retirees with the full suite of Medicare health services, but relieving the Postal Service of having to save for and provide these benefits directly. Lastly, it will set some agreed-on delivery standards for the USPS to achieve while managing cost.

As the new Illinois Chapter Legislative Vice President it is now my responsibility to organize this effort and I need as many members as we can get to come to Washington to do this. My predecessor, Marianne Miller, did a phenomenal job in organizing the Illinois Chapter member's participation in the past and has been extremely valuable in assisting me in my efforts moving forward. Once I receive confirmation on how many members plan to make the trip to Washington I will begin putting together teams that will meet with the Illinois members of the House. I will also be scheduling all of the meetings for the groups that will take place with the Illinois members of the House on Tuesday September 28<sup>th</sup>. There will be a national UMPA training session on Monday September 27<sup>th</sup> where we will learn all of the specifics of the postal reform bill and any questions will be answered in this training. We will leave this training session with enthusiasm and confidence in our ability to push postal reform. Right now I am asking everyone that plans to attend the Summit, and is not already registered, to please do so. The registration form is in this publication as well as on the National UPMA website ([www.unitedpma.org](http://www.unitedpma.org)). I am confident that postal reform will finally happen if we show up in numbers as proud members of UPMA. Remember, Together We Can!

### **Retirement Planning Starts at the Beginning of Your Career**

When someone mentions retirement planning, do you think, “I’m too young to retire,” or “Not for a few years yet.” This was the mistake that I made.

Whenever someone mentioned retirement, I would think, I have a lot of time before that happens. The truth is, planning for retirement starts on day one of your career. Retirement planning isn’t the process of retiring but the process of making sure you are ready when that time comes.

As a headquarters employee, I was offered the Voluntary Early Retirement. Although I love my job, and I am not ready to go yet, it was an eye-opener that I wasn’t financially ready to retire. I recently joined a Federal Retirement Facebook group and have been learning a lot from the posts there. I asked the members, what is something you wish you’d known or done before retiring? These were their responses:

1. Put as much in your TSP as you can. This was by far the most made suggestion. Contributions to TSP are matched by the Postal Service, so make sure you contribute at least 5%; otherwise, you’re giving up free money. Start early your contributions early in your career. The earlier you start, the more you’ll have. I know some people that increase their TSP contributions whenever they receive a raise. They were living without that money anyway.
2. Have 6 months of living expenses set aside. You don’t get your pension money right away. It takes a few months for the Postal Service to finalize your retirement paperwork. You will get interim payments, but these may not be enough to live on.
3. Live within your means and pay off your debt. You will be much more comfortable in retirement if you don’t have a lot of debt. Paying off your debts, including your house and car, makes a big difference in the amount of money your need to live off of every month.
4. Put the money in your TSP in the C & S funds. The G fund yields almost nothing. This is key. Your TSP balance will grow a lot faster in the riskier funds. Sure, you may occasionally have losses, but in the long run, the growth will far exceed the losses.
5. Make sure you have Employee Health Benefits 5 years before you retire. You can only carry your health insurance into retirement if you have FEHB coverage for at least 5 years before your retirement date. Also, keep in mind that you can only enroll during open season (unless you have a life qualifying event) so you may need to enroll a year earlier, depending on your retirement date, to hit the 5-year mark.
6. Save your Annual Leave and Sick Leave. 440 hours of AL is at least \$12,000. This response

got some pushback. Some people commented that you need to use your Annual Leave because you need a break from work. This is going to be a personal decision. If you have trouble saving money, this may be a solution to help get you through until your retirement is finalized. And while I agree that you need time off and should take it, if you save a day or two every year, you can do both. Saving your sick leave is a wise decision so you can use it if you get sick or injured. The security of knowing you won't miss a paycheck while you are recovering is well worth it. Of course, if you are sick, use it. The Post Office does add time to your years of service based on your sick leave balance. This can increase your pension payments. Research what is best for you.

7. Get help from a financial planner if you're aren't money savvy. There is no shame in admitting you aren't sure what to do. Seek help from someone that knows what they are doing. The money I have earned through the advice of a financial planner has far exceeded the money I've paid.
8. Don't wait for retirement to travel. While most of the suggestions focused on the money aspect of retirement, this was a different train of thought. I've seen a lot of people suggest this in general. If you want to travel, do it now before you are too old to enjoy it.

The hard thing about retirement is you usually only do it once, so you have little to no experience in the process. ## Letters from Veterans Spotlight: Steve Schneider, Sr.

It was the summer of 1969 and I was fresh out of high school and had no desire to go to college. The job market was not the best, and I was facing this little thing they called “the draft”. I decided to go into the Navy recruiting office along with one of my friends, and they assured me they would send me to a good training school if I would enlist for 4 years of active duty, and it was one of the best decisions I have made in my life.

My time in the Navy was 4 years of continuous good luck. In boot camp, when they found out that I had played in our high school marching band, they placed me in “Special Units”, and while the friend I joined with was marching all over with a rifle, I was practicing with the band that performed each week at the boot camp graduations.

My classification tests during bootcamp determined I was a good fit for a rating called “Communications Technician”, and when I graduated from bootcamp I was assigned to the Naval Communications Training Center in Pensacola, Florida for the next 6 months in the Cryptology section.

Following communications school, I was transferred to the Naval Communications Station on the island of Guam. An absolutely beautiful place, where the perils of World War II were still in the resident’s minds. I happened to be there in February of 1972 when a Japanese soldier name Shoichi Yokoi was discovered. He had been hiding in the jungle for 28 years hoping the Japanese army would return and he would be rescued. If you “Google” his name it makes for a very interesting story.

After 18 months on the island of Guam, I was transferred to another Communications Station in San Miguel, Philippines. Not long after I arrived, it was decided that base would be closed, and I was then transferred to the National Security Agency in Fort Meade, Maryland. While at home between those stations, I met Sue, and 13 days later, on the night before I left for Maryland, I asked her to marry me, and in May of 1973 we tied the knot. She moved out to Maryland with me until I was discharged in November of 1973 and we moved back to Illinois.

You may have noticed in the narrative that I never entered the name of a ship. Ironically, I spent 4 years in the Navy and never set foot onto a ship. My brother, Joe, another Navy Veteran, still gives me grief about that.

The things I learned in the military served me well for my Postal career. I learned how to work together toward a common goal, and lived that experience every day watching our Postal employee’s dedication in getting the mail delivered. I am quite proud of my time in the Navy, and my Postal career.

These days, Sue and I are enjoying our four grandkids and our opportunities to travel. Retirement is good!!!
