

# The Advantages of UPMA Membership

Greeting UPMA Family,

Often times while I am out recruiting new members for UPMA, I get the question,

"What is the difference between UPMA and NAPS?" This is how I answer that question.

There are only two agencies that the United States Postal Service recognizes as official organizations that they must consult with on a national level. The first one is NAPS, the National Association of Postal Supervisors, and the second is UPMA, the United Postmasters and Managers of America. Both are great organizations! The difference between the two is that NAPS is primarily a supervisory organization, and the Postal Service only consults with them on pay talks for Level 17 positions. The Postal Service consults UPMA on Level 18 positions and higher. Postmaster positions range from levels 18 through 24, and include Postal Career Executive Services (PCES) employees. Both organizations can represent any Level 17 or higher if any discipline is issued to a member.

Another difference is that UPMA only allows active postal employees to hold positions of leadership in UPMA, whereas in NAPS, many of the leadership positions are held by retired postal employees. While we have retired members of UPMA that we love and cherish, it is a fundamental belief of UPMA that it is better to have our leaders be currently employed by the USPS. Current employees know what is happening in today's Postal Service. We feel our active members are better served by current employees when discussing topics such as the "6 to 9 play", RRECS scanning, and the CRDO scorecard for example.

UPMA Leadership positions all have 3-year term limits, which means after 3 years, it's time for another member to become a leader in UPMA. NAPS does not have any term limits, and in my opinion, could perhaps lead to someone becoming too complacent in their role.

UPMA has an Associate Member program that allows our acting supervisors (204B) and other craft employees to join. NAPS does not let any craft employees join until they become a supervisor. We feel it is important to allow all employees to become Associate Members, because we realize that is how most of us started our career path to the Executive Administrative Schedule (EAS) position we now hold. We are focused on building a bench and assisting our Associate Members in their efforts to become EAS employees.

The last big difference between UPMA and NAPS is that UPMA has a program that provides our new members one year of free membership when they join, and NAPS does not. New members receive a free "1-year test drive" of the organization. We are so confident that when new members join, they will be so hooked on the benefits of UPMA, that they will never leave.

After one year, it is only \$15 per pay period, and you will have access to our Legal Defense Fund to provide you with a Merit System Protection Board (MSPB) specialty attorney if you are ever facing an adverse action from the Postal Service. UPMA represents members for less serious discipline matters, such as Letters of Warning, and 7-day suspensions, from the moment they join. NAPS does not allow any free membership period, and in fact won't even represent you in any disciplinary issues until you have been a member for at least one month. So basically, you are paying for the first month and not even eligible to be represented in any disciplinary issues.

As I said, both NAPS and UPMA are both great organizations. But, for the reasons I list above, I prefer to be an Active Member of the United Postmasters and Managers of America, otherwise known as UPMA!

## **Mitsakes** Mistakes

The next time you are presented with a mistake, whether yours or an employees, instead of jumping to anger or issuing discipline, stop, take a breath, and think about how to turn it from a negative to a positive.

Whether we like to admit it or not, everyone makes mistakes.

The key is how we respond to those mistakes. Fix it if you can — Not every mistake can be fixed. Sometimes you just have accept that it is what it is. However, if a mistake can be fixed, be sure to do it. Don't sweep it under the rug and hope no one will notice. In most instances, a mistake that is made transparent, even if it can't be corrected, is a situation that ends quickly. Issues and discipline occur most frequently when you try to cover up a mistake.

Learn – Why did the mistake happen? What can you do in the future to prevent the mistake from happening again? This is a very important step. In fact, a common interview question is, "Explain a time you made a mistake and how you corrected it." The key to answering this question is what you learned to prevent the situation from reoccurring. Don't blame – Own your mistakes. You can gain a lot of respect from coworkers and employees when you own up to your mistakes. Passing them off on someone else has the opposite effect.

Share – Let others learn from your mistakes. The ancient Indian philosopher and teacher, Chanakya said, "Learn from the mistakes of others. You can't live long enough to make them all

yourself." Helping others learn from your mistakes is the sign of a good leader.

As a Postmaster, manager, or supervisor, all the mistakes you have to deal with will not be your own. You will also have to respond to, and sometimes answer for, mistakes that were made

by your employees. When others make mistakes: Don't get angry – Anger doesn't keep people from making mistakes, it just keeps them from telling you about them. If people don't share important information with you, reflect on how you react when given information. If you get angry and fly off the handle, it is going to condition people to keep this information from you.

Assist and coach – Use mistakes as a teaching moment. You may have to fix the error, but it is much better if you can coach the person to

fix the issue themselves. This isn't always possible. If you do have to correct an error, be sure to discuss it afterwards so the teaching moment isn't lost. Think of a carrier that misdelivers an Express Parcel. A misdelivery is a hassle and inconvenience to the customer. You can apologize to the customer. However, if the carrier continually misdelivers this customer's mail, an apology no longer holds any water. The carrier must learn and develop a process to prevent misdeliveries. You can give the carrier guidance and ideas, but the best solution is going to be the one that the carrier comes up with.

Assist and coach — Use mistakes as a teaching moment. You may have to fix the error, but it is much better if you can coach the person to fix the issue themselves.

I strongly urge you to attend as we convey the needs of our employees and retirees to our congressmen. Nothing changes without constituents pleading their cases. UPMA needs you to help represent us in DC!

Also coming up soon is our annual State Convention, which will be held April 14 through April 16 in Bloomington, IL. +The registration form for this event is in this issue. If you send your registration in by March 1, 2023, and attend the entire convention, the fee will be reimbursed. There are 3 board positions that will need to be filled at this convention. After 12 years as your treasurer, I am stepping down from this position. Last year I retired, and I feel it's time to transfer my skills and support to the retiree section of this great organization! Along with the treasurer position, you will also be electing a secretary and a vice president. Anyone interested in running for a position is encouraged to do so! Please join us in April

to conduct the business of Illinois UPMA, attend educational classes, network with your peers and have some fun!

The final event I would like to mention is National Convention. This year we will be traveling to Denver, Colorado for our 7th Annual UPMA National Convention. My first national convention was in Denver in 2003 and I've attended nearly every national convention since. It has been amazing hearing our PMGs speak. I've learned so much at the training offered each year and I've enjoyed networking with postmasters from all over the United States. National Convention is truly an event no one should miss. This year Illinois UPMA is offering up to \$500.00 reimbursement of verifiable traveling expenses to all active members and retirees attending this convention. So, mark your calendars, make your arrangements, and join us in Colorado August 27th through September 1st.

Since we have so many new members attending events, I wanted to reiterate the reimbursement process. The expenses eligible for reimbursement are registration, airfare and baggage, mileage to/from airport, gas receipts if driving, hotel, and transportation fare to meetings with congressmen. These expenses must be recorded on a stipend voucher for non-board members with receipts attached. There is a separate voucher for board members. These vouchers can be found on the Illinois UPMA website. Your name badge can be used as the receipt for

registration. Actual receipts are required for all other expenses. Vouchers and receipts should be mailed to Earl Husbands for his approval. He will then mail them to me for payment. Expenses are required to be submitted within 30 days of the actual event. Late submission will require board approval for payment.

President Earl will be issuing travel orders for board members four to six weeks before each upcoming UPMA event. Travel orders will also be issued for members at large that are approved to attend. Airline tickets are not to be purchased until the receipt

of the travel order unless otherwise instructed by Earl. We also voted to require prior approval of the President for the purchase of any ticket exceeding \$500.00. Please keep these new requirements in mind when planning future UPMA travel.

# Resolution for Continuation of Illinois UPMA Chapter Dues Special Assessment

Be it resolved that the Illinois Chapter of the United Postmasters and Managers of America will continue to assess one dollar (\$1) per pay period to all active members of the Illinois Chapter to fund stipends for Illinois UPMA members to assist in expenses associated with attending UPMA events, this special assessment shall begin with Pay Period 22 FY 2023 Pay Day October 27th, 2023, and expires with Pay Period 21 FY 2024.

This fund is kept separate from the general fund and reviewed every fiscal year.

Stipends are awarded to any UPMA member for verifiable expenses incurred by attending UPMA events to include, but not limited to:

IL UPMA Chapter Convention UPMA Legislative Summit UPMA National Convention

The amount of the stipend will depend on the value of the fund and the number of stipends given. The IL Chapter Executive Board will control the amount of the stipends and direct the Chapter Treasurer to disperse the funds via expense voucher.

Verifiable expenses include:

#### Airfare

Hotel expenses at the event host hotel Event Registration at the lowest rate Gas receipts (not mileage)

To qualify for the stipend, the UPMA member must be registered for the event, attend all general sessions, participate in any mandatory meetings, and attend at least one training class that may be given at the event.

This fund was used to fund (at least in part) the following:

IL UPMA members to go to 2022 UPMA National Convention in MO

IL UPMA members to go to 2022 Legislative Summit

IL UPMA members to go to 2022 IL State Convention

Note: Per UPMA National By-Laws Article I Section 7 this resolution must be approved by a vote of the Chapter at the Chapter convention and submitted to the National Executive Board for approval. Such requests must include the reason for the special assessment and the duration of the assessment.


