

Timely Responses to Requests for Information

Hello UPMA members,

I am Tenia Thompson and your current Vice President of Education.

I would like to focus this article on RFI - Request for Information. As EAS, when we receive a Request for information from a Union Steward, no matter what craft, the first thing we should do as management is sign and date the request, indicating that we received it. Always make a copy for yourself and the EAS member that will be providing the information.

It is imperative that we respond to these requests in a timely manner. In the Chicago installation, I know they have the 48-hour rule, better known as the OBEE AWARD for the Carrier Craft. Always remember nothing in the Post Office is a secret. Provide the information that the union is requesting. If you cannot provide the information within the timeframe, always provide the union notification that you are still working on the request and additional time is needed to satisfy the request. Use Outlook to create a meeting or reminder to all your EAS staff regarding the union request so it is not left unanswered or not addressed.

Communication is key and we must adhere to the RFI deadlines. Unions are making a great deal of money due to management's lack of action; they know management is either too busy, or do not take the RFI seriously, and with no accountability nothing is going to change. Money will continue to flow into their accounts unnecessarily. Be the change for your office and provide the information that is requested.

Speak Up to Make a Difference

Hello everyone,

I want to share an inspiring story of how one person's idea made a difference. A Peoria supervisor had a question about the Postal Service's scanners, and I took it with me to the National convention in Denver, CO. Unfortunately, I had to work during the convention, so I asked the Honorable Postmaster Padric Fisher from Oregon to ask the question on my behalf. Mr. Fisher asked Dr. Joshua Colon, the vice president, and chief retail and operations officer, if the scanners could be programmed to scan parcels of a split route and tell the carrier which split the parcels go with. This would be a huge time saver, especially in larger offices with inexperienced carriers splitting up routes. Dr. Colon responded that he would contact engineering and do a cost study on the feasibility of this new program.

I am happy to report that Dr. Colon has already responded with the news that the program will be introduced in a future scanner update. This is incredible news! The convention was only at the end of August, and the field should see this update soon.

This all started with one person, Shawn Songer of Peoria, who could not attend the convention but made a difference by speaking up. Headquarters is listening, and acting, on the field's suggestions. I encourage you to attend the Chapter, Central Area (CAOS), and National conventions and experience how you can make a difference.

Postal Service Delivery Modes: From A Wild Ride to an Electrifying Experience

The history of the United States Postal Service (USPS) vehicles and delivery methods is a fascinating journey that spans several centuries. Over the centuries, many modes of transportation were utilized to transport mail efficiently and reliably. Postal service vehicles are closely tied to the evolution of mail delivery services in the United States. Below is a brief overview of delivery methods over the years:

1. Horse and Rider (1775-1820s):

- In the early days of the United States, mail was transported by horse and rider.
- Post riders carried mail between post offices, covering long distances and delivering letters and packages.

2. **Stagecoaches (late 1700s-1800s):**

- As the nation expanded, stagecoaches became a common mode of transportation for mail.
- The Postal Service contracted with private stagecoach companies to carry mail on established routes.

3. Railroads (1830s-1900s):

- The development of the railroad system in the 19th century revolutionized mail transportation.
- Railroads allowed for faster and more efficient mail delivery over longer distances.
- Mail cars were introduced to carry mail on trains.

4. Rural Free Delivery (RFD) (1896):

- RFD transformed rural mail delivery by bringing mail directly to people's homes in rural areas.
- Horse-drawn carriages and later motorized vehicles were used for RFD.
- Rural carriers initially used their own vehicles, such as bicycles and even boats in some cases.

5. Motorized Vehicles (early 20th Century):

- With the advent of automobiles, the Postal Service began experimenting with motorized delivery vehicles.
- In 1905, the first mail truck, a Cadillac, was used in a trial in Cleveland, Ohio.
- In the 1920s, the first purpose-built trucks were introduced. One of the earliest vehicles was the Ford Model T.

6. Airmail (1918-Present):

- Airmail service was inaugurated in 1918, using airplanes to transport mail across longer distances, including overseas.
- A variety of aircraft, including biplanes and later jet planes, were employed for airmail.

7. Jeeps and Military Surplus Vehicles (World War II) (1930s):

 WWII surplus military vehicles, particularly Jeeps, were repurposed for mail delivery, which were well suited for traversing rugged terrain.

8. The Grumman LLV (1980s):

- In the 1980s, the USPS introduced the Grumman Long Life Vehicle (LLV), a purpose-built mail truck that became the standard for mail delivery.
- The truck has an iconic look, with a squared-off body style.
- It is still in use today throughout the country.

9. Next Generation Delivery Vehicle (NGDV) (2015 to present):

- In 2015, the USPS launched the NGDV program to replace the aging LLVs with more modern and fuelefficient vehicles, including all-electric.
- The contract for the new vehicles, which are being built by Oshkosh Defense, was signed in February 2021 by PMG Louis DeJoy.
- Delivery of the first of the 165,000 vehicles is anticipated in 2024.

Jenny, Jenny, I Got Your Number

While attending the Legislative Summit earlier this year, I toured the Smithsonian Postal Museum and was excited to see the Inverted Jenny Stamp. My name is Jennifer, so my inner 80s child was curious. I was shocked to see how popular this stamp is. I left with souvenirs that were mainly about the Inverted Jenny. That was easy to do as there was an entire section of the gift shop dedicated to the stamp. Now let's fill you in on what the Inverted Jenny is. I have used information from the USPS.com site as well as the National Postal Museum site.

The Inverted Jenny is a 24-cent postage stamp that was initially issued on May 10, 1918, featuring the Curtis JN-4 airplane. However, there was one major problem with the design - it was printed upside down. This error has made it one of the most renowned errors in American philately (stamp collecting). Only one pane of 100 of the inverted panes was ever found, making this error one of the most valuable items for stamp collectors. Since the design required two colors, the sheets were placed on the printing press twice, which made the process prone to human error. Today, almost a century after its initial release, the misprinted 24-cent Inverted Jenny has been reprinted as a \$2 stamp and is part of the Stamp Collecting Inverted Jenny souvenir stamp sheet.

The stamp was unveiled in Louisville during the American Philatelic Society's AmeriStamp Expo at the Kentucky International Convention Center. The sheet of stamps was issued Sept. 22, 2013, to coincide with the Smithsonian's National Postal Museum opening of the William H. Gross Stamp Gallery - the world's largest stamp gallery. This souvenir sheet showcases a new version of the most famous error in the history of U.S. stamps- the Inverted Jenny. The original 1918 print mistakenly showed a biplane flying upside down. The Inverted Jennys on this sheet have been reprinted with a \$2 denomination to differentiate them from the original 24-cent ones. This sheet commemorates the many ways a single stamp can turn a moment in history upside down. The design of the new stamps uses the original engraved dies that were used to produce the 1918 Inverted Jenny.

In October 2005, a block of four Inverted Jenny stamps was sold at an auction for \$2.7 million. Two years later, a single stamp of Jenny was sold for a whopping \$977,500. In December of the same year, a mint neverhinged example was sold for \$825,000. However, the process of Jenny declined in 2008 due to a financial meltdown. Between January and September 2014, the Jenny stamps were sold for prices ranging from \$126,000 to \$575,000. Fortunately, prices did recover in 2016, and a well-centered Jenny Invert was sold at an auction for \$1,175,000. In 2018, the recently discovered position number 49 stamp was auctioned for an impressive \$1,350,000!

The stamp has become so popular that you can buy anything from a reprint souvenir stamp, pin, model plane, t-shirts, key chains, and the list continues. Even today, this stamp remains the most popular, most expensive, and most sought-after stamp.

I hope you have all seen our latest increase in CD Rates. Our 12-month CD is now at 5.01% APY, our 9 month is at 5.03% APY, our 6 month is at 5.05% APY, and as of August 10th, our Special 3-month CD is at 5.55% APY. To receive the 5.55% rate, open your account today with a minimum balance of \$500 at www.SignatureFCU.org/Certificates. (APY stands for Annual Percentage Yield). Your deposits are federally insured up to \$250,000 by the National Credit Union Administration (NCUA).

IMPORTANT NOTICE: As of August 22nd, the stand alone "MYCardRules" app will no longer be supported by SFCU. If you have not done so already, please download the SFCU Mobile Banking App as soon as possible to prevent any disruption in MyCardRules notifications.

Have you heard? Our High-Yield Checking Account just got better. You can now earn 4.00% APY on balances up to \$40,000 (we recently raised the limit from \$20,000), with no minimum balance requirements and no monthly account fee. It's another way to save big! It is available for personal and business accounts. To qualify for the rate, you are allowed only one High-Yield Checking account, your debit card must have

at least 15 transactions per month, you must have a monthly direct deposit totaling \$1,000 or more, and you must be enrolled in e-statements.

At our Signature FCU spring meeting we dedicated our building in Alexandria, VA to Joseph Gondola, a 40-year member of the Board, who served all 40 years as President. When our CEO Paula Hoelzel attended the New Jersey State Convention in June, she stopped by to see Joe and Dorothy and presented him with a photo of the dedication plaque, as well as a photo of all the Board members, Credit Committee, and Supervisory Committee present at our last face-to-face meeting in late March of this year. As you may or may not know, Joe has been in failing health this year, and I am so sorry to say, he passed away on August 17th at his home with all his family at his side.
